

THE CANADIAN REFUGEE PROTECTION PROCESS

<u>Course Summary</u>: This course provides an in-depth overview of Canada's refugee protection system, encompassing both Convention refugee claims and claims made by persons in need of protection. The eligibility to make a claim will be discussed as well as exclusion provisions. Our instructor will present strategic considerations to keep in mind from the time that a claim is being planned to the when it is made, as well as practical tips involving the preparation of the Basis of Claims, collecting and disclosing evidence, preparing clients and witnesses, as well as attending at the refugee hearing. Various ethical considerations involved in representing refugee claimants will also be discussed.
